Electronic Monitoring Program Agreement

I, ______, enter this Electronic Monitoring Agreement (hereafter referred to as "agreement"), and agree to abide by the following conditions of the Electronic Monitoring Program established by The Triton Group EHM. (hereafter referred to as "TGEHM"). <u>I ALSO</u> <u>UNDERSTAND THAT BY ENTERING INTO THIS AGREEMENT EHM IS A PRIVILEGE</u> <u>AND WILL BE TREATED AS SUCH.</u>

- A. Equipment must be worn at all times.
 - 1. I will wear the required electronic monitoring equipment 24 hrs. per day until the completion of my sentence. I will not disconnect, remove, or tamper with the monitoring equipment in any manner.
 - 2. I will maintain electric service, keep the modem plugged in, and/or a land based telephone line (depending on the system I use) at my residence and will not subscribe to any special features on my telephone (e.g. call waiting, call forwarding etc.).
 - 3. I will follow exactly the manufacturer's recommendation on the use of the equipment, if defendant/offender deviates in any part of said use; it is a violation of the agreement.
 - 4. I will allow TGEHM to inspect my home and the monitoring equipment at any time.
 - I understand that I am responsible for the maintenance and security of the monitoring equipment. If the monitoring equipment is damaged or lost, I will pay TGEHM for the cost and replacement of the equipment.

- B. Only Approved Activity Permitted
 - "Approved activity "shall mean an activity approved in advance, by TGEHM and the appropriate government monitoring agency (i.e., Court, Pre-trial Services, Parole, Probation, Etc.), such as working at your job, attending class, and attending AA meetings.
 - 2. I agree to remain at home when I am not at an approved Activity. I understand that I am accountable for my location at all times, and that my movement will be tracked and stored as official record.
 - 3. I agree to random drug testing and to follow all state and federal laws. I will submit my approved Activity schedule, in writing, during my weekly check in. Before any changes can be made to my Approved Activity schedule permission must be granted from the Court and TGEHM.
 - 4. <u>ALL REQUEST FOR ADDITIONAL ACTIVITYIES MUST BE MADE 24 HOURS PRIOR TO</u> <u>APPROVAL AND BY NOON FRIDAY BEFORE THE WEEKEND. NO EXCEPTIONS!</u>

- C. <u>Prohibited Activity</u>
 - 1. I agree not to use or possess any weapons, alcoholic beverages, or illegal drugs. I agree to submit to all substance abuse testing. A positive test will constitute a violation and breach of this agreement.
 - 2. I will obey all laws of the state. If I have any contact with law enforcement, I will notify TGEHM and the court or other appropriate governmental supervisory agency.

- D. Breaches of Agreement RITON GROUP INC
 - 1. This agreement shall be deemed violated and breached if any of the following occur.
 - a. Intentional damage is done to the monitoring equipment.
 - b. Any attempt is made to defeat monitoring.
 - c. I am arrested or commit any criminal offense.
 - d. Battery levels falls below 30% of full charge
 - e. I leave the jurisdiction of the court or enter areas that are "off limits".
 - f. I enter any tub, pool, or other body of water. You may shower with equipment.
 - g. I violate any other term of this agreement, Court order, The Triton Group EHM or Triton Recovery INC.

- 2. I understand that if I breach this Agreement, TGEHM may immediately remove me from the Electronic Monitoring Program. I further understand that a breach of this agreement may result in the filing of a probation/bail release Violation Report, petition to Revoke Probation/Bail release.
- 3. I ALSO UNDERSTAND THAT IF FOR ANY REASON I OR TGEHM TERMINATE MY LEASE EARLY I AM RESPONSIBLE FOR THE FULL AMOUNT OF THE CONTRACT BILLED.
